- The DHC's director Catherine Davies has been appointed a specialist member of the Health and Social Care Committee's expert panel evaluating the government's progress in achieving its commitments made regarding the digitisation of the NHS.

- Cabinet office clamps down on trust spending freedom
 - HSJ revealed that NHS trusts will have to receive Cabinet Office approval for any clinical and non-clinical spending over £10m.
 - The new controls will be introduced by NHS England in London first and then rolled out to the other regions over the next two years.

 - More than one thousand GP assistants will be recruited to practices from this month to offer more admin support with the roles already proven to reduce the time GPs spend on tasks such as writing letters by more than two-fifths.
 - GP assistants will be trained to do blood pressure checks, heart rate and blood tests as well as arranging appointments, referrals and follow-up care for patients.
